| <p><u>Draft Law of Ukraine “On amending the Law of Ukraine “On citizens’ participation in public order enforcement and the state border surveillance” (regarding organization of functioning of civil formations)</u> (No. 2144a of 22 June 2015, Cabinet of Ministers of Ukraine)</p> | <p>Included into Agenda on 14 July 2015</p> | <p>Changes are aimed at addressing problems arising in practice in the process of application of the said Law regarding creation and organization of functioning of civil formations for public order enforcement and the state border surveillance.</p> |
| <p><u>Draft Law of Ukraine “On amending the Law of Ukraine “On ensuring rights and freedoms of individuals and legal regime on the temporarily occupied territory of Ukraine” (regarding abolishment of pass permits and definition of transparent rules of movement of persons and cargos (goods) through the temporarily occupied territory)</u> (No. 2004a-1 of 17 June 2015, MP N.V.Veselova)</p> | <p>Sent to the MPs for review on 19 June 2015</p> | <p>The draft is meant, <i>inter alia</i>, to legislatively regulate entry of citizens of Ukraine, foreigners and stateless persons to the temporarily occupied territory of Ukraine and exit from it, namely with an identity/passport document only without presenting any other documents.</p> |
| <p><u>Draft Law of Ukraine “On amending the Law of Ukraine “On ensuring rights and freedoms of individuals and legal regime on the temporarily occupied territory of Ukraine” (regarding improvement of the legislation on the temporarily occupied territories)</u> (№ 2004a of 3 June 2015, MP A.V.Parubiy, MP A.M.Levus, MP S.V.Vysotskyy and others)</p> | <p>Submitted in substitution on 14 July 2015</p> | <p>The draft envisages introduction of a special regulatory approval system for entry of persons to the temporarily occupied territory and exit from it, namely special permits for entry or exit from these territories for citizens of Ukraine and not only for foreigners and stateless persons (as envisaged by the Law presently in force).</p> |
| <p><u>Draft Law of Ukraine “On denunciation of the Agreement between the Cabinet of Ministers of Ukraine and the Government of the Russian Federation “On cooperation in the course of joint control of persons, vehicles and goods at the Ukrainian-Russian state border”</u> (No. 0043 of 30 June 2015, MP Y.M.Bereza)</p> | <p>Sent to the MPs for review on 2 July 2015</p> | <p>The author of the draft Law considers it necessary to change the regime of legal regulation of the state border between Ukraine and the Russian Federation. According to the explanatory note “successful countering Russian aggression, <i>inter alia</i>, demands implementation of the regime of rigid and effective defense of the state border of Ukraine and prevention of its illegal crossing by people or cargos”.</p> |

[Resolution of the Cabinet of Ministers of Ukraine of 27 May 2015 No. 349 “On amending Annex 1 of the Resolution of the Cabinet of Ministers of Ukraine of 5 April 2015 No. 85”](#)

Will enter into force on 1 January 2016

From 1 January 2016 the maximum number of the employees of the State Migration Service of Ukraine and its regional departments is increased from 186 to 216 and from 4613 to 5083 respectively.

[Resolution of the Cabinet of Ministers of Ukraine of 4 June 2015 No. 357 “On approval of the Agreement between the Government of Ukraine and the Government of the Republic of Tunisia regarding mutual abolishment of visa regime for diplomatic, service and special passport holders”](#)

Entered into force on 12 June 2015

The respective Agreement signed in Dakar on 29 November 2014 is approved.

[Resolution of the Cabinet of Ministers of Ukraine of 4 June 2015 No. 365 “On approval of the Second Protocol between the Cabinet of Ministers of Ukraine and the Government of the Republic of Poland regarding amendments to the Agreement between the Cabinet of Ministers of Ukraine and the Government of the Republic of Poland regarding the rules of local border traffic signed on 28 March 2008 in Kyiv”](#)

Entered into force on 12 June 2015

The respective draft Protocol signed in Warsaw on 17 December 2014 is approved by this Resolution. The draft envisages amendments to the said Agreement which regulates the rules of local border traffic at the Ukrainian-Polish state border.

[Resolution of the Cabinet of Ministers of Ukraine of 4 June 2015 No. 356 “On approval of the Procedure for supporting functioning of foster families, family-type orphanages who moved from the temporarily occupied territory or the area of the antiterrorist operation”](#)

Entered into force on 19 June 2015

The approved Procedure defines a mechanism for supporting functioning of foster families, family-type orphanages who moved from the temporarily occupied territory or the area of the antiterrorist operation and also payment of the state social security benefits to orphan children and children deprived of parental care, monetary benefits to foster parents and adoptive parents for provision of social services at family-type orphanages and foster families under the principle “money follows a child”.

Due to liquidation of the State Registration Service of Ukraine the Ministry of Justice of Ukraine was defined as a holder of the State Register of Civil Status Acts.

The Resolution is adopted according to the Law of Ukraine “On the central bodies of

executive power” according to which the Statutes of ministries and other central bodies of executive power are approved by the Cabinet of Ministers of Ukraine. The previous Statute of the Ministry of Social Policy of Ukraine was approved by the Decree of the President of Ukraine.

The Ministry of Social Policy of Ukraine is responsible for formation and implementation of the state policy, *inter alia*, in the sphere of labour migration, countering trafficking in human beings, protection of the rights of persons deported based on national identity and who returned to Ukraine.

The said draft Agreement was endorsed by this Decree.

[Decree of the Cabinet of Ministers of Ukraine on 4 June 2015 No. 582-r “On submission for ratification by Verkhovna Rada of Ukraine of the Agreement \(in the form of exchange of notes\) between the Cabinet of Ministers of Ukraine and the Government of the Republic of Poland regarding mutual employment of family members of the staff of the diplomatic missions abroad”](#)

Entered into force on 4 June 2015

The said Agreement signed in Warsaw on 27 February 2017 was submitted for ratification.

Entered into force on 5 June 2015

Measures envisaged by the Decree were developed with account of recommendations of the Fifth Progress Report from the European Commission to the European Parliament and the Council on the Implementation by Ukraine of the Action Plan on Visa Liberalisation regarding improvement of the person identification system.

Resignation of the Head of the State Migration Service of Ukraine S.I.Radutnyy is accepted.

The Agreement submitted for ratification was signed in Gomel on 23 January 2013. The ratification of the Agreement will create favourable conditions for crossing the Ukrainian-Belarusian state border at the local (facilitated) checkpoints by the residents of the near-border districts of Ukraine and the Republic of Belarus.

The Strategy is aimed at implementation by 2020 of the priorities of the national security state policy. Among these priorities are, *inter alia*, development of the State Border Guard Service of Ukraine and of the State Migration Service of Ukraine.

Due to staff changes in the state authorities the personal composition of the Presidential Commission in the matters of citizenship was updated. Deputy Head of the State Migration Service of Ukraine T.V.Nikitina and First Deputy Head of the State Border Guard Service of Ukraine V.M.Servatyuk are members of the Commission.

A new ground for reentry ban for a foreigner or a stateless person is an attempted entry by the latter to the temporarily occupied territory of Ukraine without a special permit.
