In partnership with *PricewaterhouseCoopers*, IOM will prepare policy recommendations and action plan on enabling migrant investments in Ukraine. Best investment mechanisms for Ukrainian migrants and diaspora will be identified.

Nearly 3 million Ukrainians benefited from visa-free regime with the EU

Since the launch of the visa-free regime in June 2017, Ukrainians have made 42.6 million trips to the EU countries. As many as 9.2 million citizens of Ukraine crossed the border with biometric passports, almost 3 million biometric passports holders took advantage of the visa-free regime. To date, 157 checkpoints across the state border of Ukraine are equipped with biometric control tools and connected to Interpol databases, and modern technical means allow them to check all types of biometric documents automatically.



OSCE SMM records five-fold increase in shelling in the Donbas

The OSCE Special Monitoring Mission to Ukraine (SMM) recorded a sharp increase in ceasefire violations in the Donbas. The OSCE SMM informed this in a report, based on information received as 21 June, 2019. In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (about 380), compared with the previous reporting period (about 70 explosions); In Luhansk region, the Mission recorded more ceasefire violations, including, however, a similar number of explosions (165), compared with the previous reporting period (about 170 explosions).



Ukraine and Costa Rica agree on visa-free regime

According to the Consular Service Department of the Foreign Ministry of Ukraine, for the first time in the history of bilateral relations, two friendly countries held negotiations on consular issues. The delegations analyzed the state and prospects of cooperation in the migration and visa sectors, discussed the issue of protecting the rights and interests of citizens and legal entities of both countries, and discussed prospects for expanding the mutual consular presence. In addition, the parties reached an agreement on concluding a bilateral agreement on visa-free travel.



At least 240,000 Ukrainians make their homes in Italy

Italy has long been one of the top destinations for Ukrainian labour migration in Europe. According to the Ukrainian Embassy in Italy, there are officially more than 240,000 Ukrainians living there, with unofficial estimates running as high as 500,000. But Ukrainians are ranked 20th place among Italy's foreigners by economic activity, according to the embassy. Most of them have service jobs that are not popular among locals: babysitting children, taking care of the elderly, cleaning and farm work.
